

RESOLUTION NO.

A RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA BARBARA ESTABLISHING CERTAIN CITY FEES AND RESCINDING RESOLUTION NOS. 88-026, 92-083, 93-113, 96-078, 97-014, 03-050, 03-051, 03-052, 03-053, 03-054, 03-055, 03-057, 03-058, 03-059, 03-060, 03-061, 03-062, AND 03-106

WHEREAS, the City provides, maintains and operates a variety of programs and services to the public;

WHEREAS, certain sections of the state and municipal code authorize the imposition and collection of fees to defray the costs of providing certain programs and services; and,

WHEREAS, certain fee schedules as attached cite the specific state or municipal authority under which fees and charges are collected.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SANTA BARBARA THAT:

Section 1. The Council hereby determines and finds that:

a. Funds are needed to defray the cost of providing programs and services furnished by the City.

b. The funds needed to defray such operating expenses can and should be obtained by setting fees and charges for these programs and services.

c. The setting of fees and charges for these programs and services is exempt from compliance with the requirements of the California Environmental Quality Act (CEQA) under Public Resources Code Section 21080(b)(8)(1)-(4) and Title 14 of the California Administrative Code, Section 15273(a)(1)-(4).

Section 2. The fees and charges for the Fiscal Year 2005 are adopted as set forth in the City of Santa Barbara Schedule of Penalties, Fees, and Service Charges for Certain City Departments, attached hereto.

Section 3. Resolution Nos. 88-026, 92-083, 93-113, 96-078, 97-014, 03-050, 03-051, 03-052, 03-053, 03-054, 03-055, 03-057, 03-058, 03-059, 03-060, 03-061, 03-062, and 03-106 are hereby rescinded.

Section 4. All other fee resolutions in effect and not rescinded herein, shall remain in full force.

ANIMAL CONTROL FEES

Section 6.12.050 of the Santa Barbara Municipal Code authorizes the City Council to set fees and charges for custody or control of dogs.

1. The license fee shall be \$30.00 for each dog in the city, regardless of sex, over the age of four months, or \$15.00 for any dog that has been spayed or neutered.
2. The fee for a duplicate dog license shall be \$7.50.
3. Senior citizens (people 76 years or older) shall be charged \$15.00 for each dog in the city, regardless of sex, over the age of our months, or \$7.50 for each dog that has been spayed or neutered.
4. The penalty fee for a delinquent dog license shall be \$15.00.
5. The six-month rate is half of the annual fee.

ANIMAL REMOVAL FEES

Section 6.24.010 of the Santa Barbara Municipal Code authorizes the City Council to set fees for the disposition of animals.

1. The animal disposal fee for the first animal picked up at a specific address or location at a specific time shall be \$15.00.
2. The animal disposal fee for any additional animal picked up at the same specific address or location, at the same specific time, shall be \$2.00.
3. The euthanasia fee shall be \$10.00 for each animal.

CITY CLERK INITIATIVE FILING FEE

The California Elections Code was amended in 1987 requiring that the proponents of any initiative petition file with the City Clerk a Notice of Intent to circulate petitions (Elections Code Sections 4002 and 4002.5) to which the City is obliged to prepare a ballot title and summary within fifteen days.

Notice of Intention Filing \$ 200.00

The filing fee for the Notice of Intention will be refunded to the filer if, within one year of the filing, the City Clerk certifies the sufficiency of the petition.

CITY TV VIDEO DUPLICATION FEES

The City of Santa Barbara televises and videotapes public meetings and produces video programs of public interest, copies of which are available to the public upon request.

COMMUNITY DEVELOPMENT PLANNING AND BUILDING AND SAFETY FEES

The City's Community Development Department provides important services to the public in the areas of construction safety, planning, housing, and land use. The department has four divisions: Planning, Housing and Redevelopment, Administration, and Building and Safety, as well as numerous committees.

For each enumerated fee set forth in the schedule below, included is a Records Management fee equal to 5% of the fee for the listed service. The 5% Records Management fee is necessary to defray the cost of providing Records Management services, with respect to the listed activity.

For site development, activities areas, or combination of structures and/or site changes, the fee per square footage is not limited to the building area, but may involve the site area.

At the discretion of the Library Director, the above fees may be waived for City and County governmental agencies, and for those activities which are endorsed or provided as a part of the Library program.

SECTION III. EXTENDED USE FEES

A. The following schedule of fees shall apply to all books and other materials which are not returned on or before the due date:

- B. Extended use fees begin accumulating on the day following the due date and accrue for each succeeding day including weekends and holidays. Patrons designated in the “exceptional” category (using large-print, Braille or shut-in services) are not charged for materials returned past the due date.
- C. Suspension of Library Privileges. Patrons accumulating charges of ten dollars (\$10.00) or more may have library privileges suspended until such time as full payment is received.
- D. Materials Not Subject To Extended Use Fees. No overdue fees shall be imposed for un-catalogued paperbacks, pamphlets, or picture file materials.
- E. Waivers. The extended use fees provided herein may be waived by the Library Director if it is determined that the patron’s failure to return the library materials is due to exceptional circumstances over which the patron had no control.

PARKING VIOLATION PENALTIES AND RELATED FEES

Assembly Bill 408, effective July 1, 1993, amended the California Vehicle Code to decriminalize parking tickets and to eliminate criminal court procedures for the enforcement of such violations, such that the issuance, collection and enforcement of parking or standing vehicle violations became a civil matter under the California Vehicle Code.

Section 40203.5 (a) of the Vehicle Code requires the City Council to establish a schedule of parking penalties for parking violations, late payment penalties, administrative fees, and other related charges for parking violations. It is the intent of the City of Santa Barbara that the penalties established herein shall reflect a reasonable and good faith effort to establish appropriate penalties.

SANTA BARBARA GOLF CLUB

Regular Green Fees

Regular Green Fees shall be as set forth in the Parks and Recreation Department FY 2004-2005 Schedule of Fees and Charges subject to these Rules and Regulations.

Regular green fees, including Resident Green Fees Discount Rates and 7-Day Green Fees Discount Rates, apply on the following City holidays during FY 2004-2005:

Eligibility for Resident Discount Rates

Santa Barbara and Ventura County residents may receive the Resident Green Fees Discount Rates available with the payment of the appropriate fee and the required proof of residency. A resident must be 18 years of age to be eligible for the resident discount. The Resident Green Fees Discount is valid for one year from the date of purchase.

Proof of residency shall be provided at the time of purchase by presenting a current California Department of Motor Vehicles Driver's License or California Department of Motor Vehicle Identification card, with a Santa Barbara or Ventura County street address and zip code of residence printed by the California Department of Motor Vehicles on the face of the driver's license (P.O. Boxes are prohibited). No exceptions shall be made.

Resident 5-Day and 7-Day Green Fees Discount Rates

Santa Barbara and Ventura County residents may purchase a 5-Day Green Fees Discount for an additional \$60.00 or a 7-Day Green Fees Discount Card for an additional \$85.00. In order to purchase either discount, residents must: 1) have already purchased a \$15.00 Santa Barbara or Ventura Resident Golf Green Fees Discount; or 2) show proof of residency, as stated in the policy above, and pay \$75.00 for the 5-Day Annual Discount and the Santa Barbara or Ventura Resident Golf Green Fees Discount or \$100.00 for the 7-Day Annual Discount and the Santa Barbara or Ventura Resident Golf Green Fees Discount.

Five-day discounts are valid Monday through Friday (excluding holidays). Seven-day discounts are valid every day the course is open.

Twilight Times

Twilight Times: After 12:30 p.m. Oct. 1 - Jan. 31; after 1:00 p.m. Feb. 1 – Apr. 1; after 2:00 p.m. Apr. 2 – Sept. 30.

Minimum Age for Senior Discount

A player must be at least 65 years of age to be eligible for the senior rate.

Junior Rates

A player must be 17 or younger to be eligible for the Junior Rate.

Players 17 or younger are not eligible for the 5-Day or the 7-Day discount privileges.

There is no distinction between resident and non-resident for Junior greens fee rates.

A Junior rate is available anytime except before Noon on weekends (Juniors pay same as Adults before Noon).

Home Club and Senior Weekday Group Policies

The Home Club events or tournaments shall not start before their approved times on their approved days.

The authorized Home Clubs are:

Santa Barbara Men's Golf Club (2nd Monday; 3rd Sunday – each month – 9:00 a.m.)
Santa Barbara Women's Golf Club (Every Wednesday – 9:00 a.m.)
Executive Women's Golf Association [Santa Barbara Chapter] (1st Sunday – 9:00 a.m.)
Los Paisanos (4th Sunday – 9:00 a.m.)
Hits and Misses (2nd Sunday – 10:30 a.m.)
Tuesday Swingers (Every Tuesday – 9 holes/ladies – 10:30 a.m.)

A Senior Weekday Group, in order to qualify for designated tee time blocks, must be in existence for at least ten years. Not more than seven groups will be authorized. Authorized Senior Weekday Groups will not secure the times outside of designated tee time blocks. Senior Weekday Groups will pay a one dollar (\$1.00) surcharge for each player each time they play. The group must make reservations one week in advance and pay the surcharge fees at that time.

Chersky Group (every Monday – 9:00 a.m.; every Wednesday – 8:15 a.m.; every Friday – 9:00 a.m.)
Tuesday SR's (every Tuesday – 9:00 a.m.)

Thursday SR's (every Thursday – 10:00 a.m.)

Tournament Rates

The Tournament rate applies to all tournament groups except for the Parks and Recreation Commission authorized Home Club Groups.

Tournament Policies

Policies for tournaments at the Santa Barbara Golf Club shall be as follows:

a. All major invitational tournaments, during which the Santa Barbara Golf Club is closed to the public, must be approved by the Park and Recreation Commission. The Santa Barbara Golf Club shall not be closed to the public for major invitational tournaments for more than a total of four (4) days annually.

There are two major invitational tournaments approved annually:

Weekend) Santa Barbara City Golf Championship (Memorial Day

The Classic (First weekend in August)

b. The City shall not be responsible for the management or distribution of prizes for tournaments it does not conduct;

c. The sponsor of a major invitational tournament shall submit to the City's Parks and Recreation Director within ten days of the termination date of the tournament, a written accounting of all income and expenditures;

d. The Parks and Recreation Director is authorized to determine and set general rules and regulations regarding tournament scheduling. The Golf Professional, in accordance with policies and procedures established by the Parks and Recreation Director, shall schedule group tournaments. Tournaments shall not start before 10:00 a.m. Standard Time and 11:00 a.m. Daylight Time. The Parks and Recreation Director is authorized to approve special tournament play at times not consistent with established policy when such play would benefit the course related to publicity, promotions and revenue; and

d. The Tournament rate applies to all tournament groups except for the Park and Recreation Commission authorized Home Club groups. Resident Green Fees and 5-Day and 7-Day Discount Rates are not valid for Tournament Groups except for approved Home Clubs.

f. Requests for waiving green fees for junior tournaments shall be made in writing to the Park and Recreation Commission. The Park and Recreation Commission shall have authority to waive fees when appropriate and advisable.

Courtesy Play:

Courtesy play (no green fees) may be extended to the following individuals on the following conditions:

a. The Golf Professional and ten (10) course marshals, other current Class A members of The Professional Golfers' Association of America, and current PGA apprentices;

b. The policy for courtesy play for members of school golf teams shall be determined by the Parks and Recreation Director and shall be approved by the Park and Recreation Commission.

Rain Checks

The Parks and Recreation Director shall have authority to establish and administer "rain check" policies for paid green fees when weather conditions prohibit play after a fee is paid.

TENNIS PROGRAMS

The following rules and regulations shall apply to the use of public tennis courts owned or operated by the City:

Annual and Daily Permit

Annual and daily permits shall be mandatory for use of the:

Municipal Tennis Center
Las Positas Tennis Courts
Pershing Park
Santa Barbara High School tennis courts

There is no permit required, nor any fee charged, for the tennis courts at Oak Park.

Credit: When an individual purchases an annual permit, a \$4.00 credit (\$5.00 for non-residents) will be given for one (1) daily permit turned in that said individual has purchased within the previous thirty days.

Daily permits shall be valid only for the day stated on the face of the permit. Any permit, which has been altered, shall be void.

- A) Permits shall not be transferred.
- B) Permit fees are not refundable.
- C) The purchase of permits does not require membership in any tennis organization.
- D) Lost or stolen permits shall not be replaced.
- E) City may schedule activities on the Las Positas, Pershing Park, Municipal and Santa Barbara High School Tennis Courts such as tournaments, lessons, rentals, leagues or other special activities, which may prevent the use of said courts by permittees at certain times.
- F) Permit holders agree to abide by all Court rules and City regulations including the Code of Conduct.

Applicable fees and charges for tennis programs are specified in this Schedule of Fees and Charges, subject to these rules and regulations.

COMMUNITY CENTERS

Lease Rental Rates

The lease rental rate for occupied space and allocated common area space at Louise Lowry Davis, Franklin and Westside Centers shall be as specified in this Schedule of Fees and Charges.

Occasional Use

The criteria for rental categorization for fees charged, as specified in this Schedule of Fees and Charges, for Occasional Use of the conference rooms and other activity spaces located in the Louise Lowry Davis, Franklin, Westside and Lower Westside Centers are as follows:

<u>Classification</u>	<u>General Description</u>
A	Community Service clubs and organizations; fraternal groups; volunteer service organizations; non-profit single purpose interest groups; and educational institutions.
B	Commercial and private activities.

Franklin Neighborhood Center and Westside Community Center lessees may conduct bingo games in common area meeting rooms for the purpose of fundraising, pursuant to Municipal Code Chapter 9.26. Individuals or groups that are not Franklin Neighborhood Center or Westside Community Center lessees may conduct bingo games for entertainment purposes only.

**Indoor and Outdoor Facility Rentals
Photography/Filming
Special Events**

GENERAL USE AND FEES

Indoor and outdoor facilities may be reserved and rented on a first-come, first-served basis per established City Council policies. The following fees and policies relate to use of facilities, equipment and staff services. Advance payment of the permit application and reservation fees are required to hold a reservation. (In certain limited situations, such as sport related special events, a minimum deposit of \$100 must be paid to hold a date, as determined by staff.) Facility use fees, security deposits, janitorial and monitor fees must be paid no later than two weeks prior to facility use, or earlier as determined by staff.

<u>Classification</u>	<u>User Type</u>
A	Community service clubs and organizations, fraternal groups; Community and volunteer service organizations; Educational institutes; Non-Profit single purpose interest groups
B	Commercial or Private Groups
C	City Parks and Recreation Department sponsored or co-sponsored activities or other City agency official use, including use of a facility as a polling place. No charge.

Fees Determined Annually, effective July 1: Fees as adopted by City Council for the fiscal year take effect July 1 each year and will be applied to all facility uses after that time, regardless of when the permit application was initially processed or whether any portion of fees payment has been paid. This notice will be given to all permit requests/applications at the time of reservation or permit processing.

Permit Application Fee: A non-refundable fee of \$5 is charged for facility use permits obtained by all classifications listed above except "C". This fee is charged for each permit issued (including duplicates) and when reservations are changed by applicant.

Security Deposits: Security deposits are required for all indoor and outdoor facility rentals. The security deposit may be applied toward additional charges, fees or penalties including, but not limited to: failure to return facility keys, oversized groups, damage repairs, additional custodial fees, unscheduled staffing due to late departures and/or any expenses related to non-compliance with the stated facility use rules, or as deemed necessary by staff.

Indoor Facilities
Deposit amount varies by facility: \$150-\$500

Outdoor Facilities
Deposit amount determined by group size:
1 – 25 people \$25
26 – 75 people \$50
76 – 125 people \$100
126 – 200 people \$125
201 – 300 people \$200

Special deposits or bonds may be charged for special events or groups exceeding 300 persons.

Custodial Fees: Most facilities require payment of custodial services as part of the facility use. Fees vary by facility and are intended to cover full custodial cost related to use, as determined by the Director.

Monitor Fees: As determined, some facility rentals (indoor and outdoor) will be charged for event monitors as part of the facility use. Fees vary by type, size and location of the event, and are determined by the Director.

Private Security: As determined by the Director, some facility rentals (indoor or outdoor) will be required to provide private security services as part of the facility use. Requirements vary according to the type, size and location of the event, and whether or not alcoholic beverages will be served.

Fines for Misuse of Sports Fields: Fines will be assigned for sports league teams that misuse fields during the rainy season. Misuse will result in forfeiture of permits and/or fines from \$30 to \$125, depending on the extent of turf damage. Fines of \$30 will be assessed for each violation listed below and must be paid prior to the next league game.

- 1) Use of MacKenzie Park Youth Baseball diamonds for any softball practices.
- 2) Use of Santa Barbara City College baseball diamond infield.
- 3) Any team found practicing on softball infields prepared for league games.
- 4) Use of soccer or softball fields for practice by any soccer or softball team.

Miscellaneous Fees: The Parks and Recreation Director may establish miscellaneous fees or charges for parks, beaches, facility equipment and services not identified in this schedule; provided the assessment is in line with existing policies governing use of City property. For example, charges may be required for extra custodial supplies or special public notices or signs if a facility is to be closed because of permitted use. Also, additional charges may be assessed related to unusual uses of City parks, beaches or facilities, such as televised broadcasts, extensive equipment setups over several days, or as compensation for significant impacts to local neighborhoods related to parking, noise, congestion, etc. Applicants may be required to provide, at their own expense, additional portable restrooms and trash bins at locations designated by the Director, and other items deemed necessary.

Use of Facilities for City Department Social Functions: Discounted fees for City employee use of reservable areas within parks, beaches and recreation facilities are limited to department social functions (including retirement parties). In order to qualify for the discounted fees described below, the function must be:

1. Endorsed by the requesting department's Director;
2. Open to all employees of the requesting department (if not the entire City staff); and,
3. Approved by the Parks and Recreation Director.

Non-Prime Time (Monday through Thursday)

Application fee, facility use fee and security deposit will be waived. Set-up/breakdown fees, monitor fees and custodial fees will not be reduced or waived.

Prime Time (Friday, Saturday and Sunday)

Application fee and security deposit will be waived. Facility use fee will be reduced to one half of the designated non-profit rate or to one half of the facility use fee applicable to size of group for the site. Set-up/breakdown fees, monitor fees and custodial fees will not be reduced or waived.

Various fees related to facility use are described within the Schedule of Fees & Charges.

OUTDOOR RENTAL FACILITIES

Categories:

- Picnics I, II, III, IV – based on group picnic area capacity
- Private Gatherings I, II, III, IV – Corporate or Individual
- Wedding Ceremonies I, II, III – limited to 4 hours, can include locations other than designated reservable areas
- Sporting Events I, II, III, IV – Runs, Walks, Tournaments, etc.
- Public Events I, II, III, IV, V, VI – any event open to the public

The City of Santa Barbara provides the opportunity for public and private use of City parks and parkland. Such use may include picnics, wedding ceremonies, and public or private gatherings, sporting events such as walks and runs, or large community special events. Fees are determined by the size, scope and duration of the event, except for group picnic sites, which are based on the site's area capacity. The following fee table describes categories and fee levels for various uses.

Set Up and Break Down Days: For larger outdoor events with extensive set up including canopies, stage, etc., set up and break down days will be assessed 25% of the daily reservation fee per day or any part of one day. Dumpsters and portable toilets are exempt from the break down day charge if they are removed by 9am the following day.

Utility Hook Ups for De La Guerra Plaza Events: Utility hook ups for gas, water and electric may be made available for large special events with multiple food vendors held in De la Guerra Plaza. The Parks and Recreation Department will facilitate the hook up requests through the Public Works Department, and approval is dependent upon Public Works ability to schedule the necessary personnel to complete the required work for the event in the given timeframe. (Non-city worker may not be used to activate utility hook ups.) Requests must be submitted a minimum of three weeks in advance of the event. A deposit of \$800 is required to cover estimated charges. Following the event, a refund will be processed for any deposit amount that exceeds the actual costs incurred. If an event is cancelled for any reason, the event will be billed for all work completed up through that time, including deactivating the hook ups.

VEHICLES IN PARK OR BEACH AREAS RELATED TO PERMITTED EVENTS

The use of vehicles in parks and beaches is strictly controlled and restricted to authorized uses only. Authorized passes will be limited to vehicles deemed essential to the operation of the permitted event, as determined by the Director or designated representative. This includes vehicles unloading or loading equipment, supplies or passengers, or other types of vehicles related to the event.

Unauthorized driving or parking of vehicles in park or beach areas related to permitted events will be cited and fined \$50 per vehicle. Unauthorized driving or parking may include vehicles without access permits or authorized vehicles, which do not comply with driving conditions as determined in the permit. Fines will be charged to the event and withheld from the security deposit. Excessive abuse of the vehicle policy by an event may affect future event permit consideration.

OUTDOOR RENTAL FACILITIES

The following fee table provides general categories of events and pricing for events held in City parks. Although specific events may vary slightly within a designated category, the description is intended to provide a guide for categorizing events properly. Final fee designation is made by the Parks and Recreation Director or his/her designee. The Parks and Recreation Director reserves the right to determine fees outside of this fee table for certain events, characterized by unique or untypical location. Type of activity, duration, size, or scope. Resident discount is applied to applicants (legally responsible party) with a resident discount card.

PHOTOGRAPHY AND FILMING

Photography and Filming - Use of Parkland, Beachfront and the Santa Barbara Golf Club: In addition to any permit fees charged by the City, there shall be a separate charge for photography and filming of any golf course, parkland or beachfront areas under the Parks and Recreation Department jurisdiction. Factors considered for setting fees include impact to parkland or facilities utilized, any restriction to public access, props, number of people involved, and any related costs.

Proof of Insurance: All permits must be accompanied with proof of insurance, \$250,000 to \$1,000,000 as determined by Risk Management.

Late Request Service Charge: \$100. May be applied to permits received after the permit filing date, which is two weeks prior to the event.

Student Projects: Student projects may be conducted free of charge if they can be categorized into Level 1 (below). A letter on school letterhead must be submitted stating that the permittee is conducting a school project.

Non-commercial still photography: \$75/day. The Parks and Recreation Director or designee may waive fees for non-profit organizations, government or educational projects, based on the nature of the request. Other fees may be applied as determined by staff and the nature of the request.

Stock/portrait photography: Free one-year permit with verification of City Business License and proof of insurance.

Commercial Still Photo and Film Shoots: Uses are categorized into three levels for each type of shoot. The following fee table provides general categories of events and pricing. Although specific uses may vary slightly within a designated category, the description is intended to provide a guide for categorizing events properly. Final fee designation is made by the Parks and Recreation Director or his/her designee. The Parks and Recreation Director reserves the right to determine fees outside of this table for certain events, characterized by the unique or untypical location, scope, size or duration of the event, and/or impact to public parkland as a result of the use.

SEWER RATES AND FEES

Title 14 of the Santa Barbara Municipal Code authorizes the City Council to set water and sewer service charges;

Section 14.40.010 of the Santa Barbara Municipal Code authorizes the establishment by resolution of sewer service charges for sewer service connections to premises within the City Limits of the City of Santa Barbara; and

Title 16 of the Santa Barbara Municipal Code authorizes the City Council to control and regulate discharges into the sewer system and to establish quantity standards, fees and controls for dischargers.

Definitions

Wherever used in this resolution, the following words shall have the meanings set forth beside them:

- A. "Composite sample." Two or more aliquot samples taken from the same waste stream over a period longer than fifteen (15) minutes.
- B. "Director." The Director of the City Public Works Department or his or her designated representative.
- C. "Hcf." 100 cubic feet.
- D. "Sewer" or "City sewer system." Any and all artificial conduits owned and operated by the City or any other public agency that are tributary to any wastewater treatment facility operated by the City.
- E. "Waste." Sewage and any and all other waste substances, liquid, solid, gaseous, or radioactive, associated with human habitation, or of human or animal origin, or from any producing, manufacturing or processing operation of whatever nature.
- F. "Wastewater." Waste or water, treated or untreated, which is discharged into or permitted to enter a sewer.

1. Sewer Service Rates.

The following monthly rates and charges shall apply to use of sewers by the following categories of customers:

A. Residential

Service Charge

- 1. Applicable to all accounts serving one detached dwelling unit:

- i. Basic charge: \$9.51
 - ii. Plus, charge based on the quantity of water consumed:
 - 1 Hcf to 10 Hcf: \$1.64/Hcf
 - Over 10 Hcf: No additional charge
2. Applicable to all accounts serving two or more detached dwelling units and all accounts serving 1, 2, 3 or 4 attached dwelling units:
- i. Basic charge per dwelling unit: \$9.51
 - ii. Plus, charge based on the quantity of water consumed per unit:
 - 1 Hcf to 8 Hcf: \$1.64/Hcf
 - Over 8 Hcf: No additional charge
3. Applicable to all accounts serving five or more dwelling units, any of which are attached.
- i. Basic charge per dwelling unit: \$9.51
 - ii. Plus, charge based on the quantity of water consumed per unit:
 - 1 Hcf to 7 Hcf: \$1.64/Hcf
 - Over 7 Hcf: No additional charge
4. If a dwelling unit does not receive City water service, the unit shall be charged the maximum rate from the appropriate category, regardless of the quantity of water used.

B. Commercial.

Applicable to all commercial, office and institutional buildings, including hotels/ motels (except those with restaurants or other food processing facilities), schools and churches, and self-service laundromats, provided that discharge there from is limited to wastes typical of domestic wastewater, the greater of:

Also applicable to paint manufacturers; laundries (other than self-service laundromats); car washes; metal plating works; other industrial establishments; and other commercial establishments with waste characteristics similar to those included above. The quantity of "water consumed" refers to the quantity of metered water service, other than through irrigation meters, provided monthly to a parcel having one or more connections to the City sewer system. Where the quantity of wastewater which enters the sewer connection(s) to a particular parcel is substantially less than the quantity of metered service to the parcel, a sewer service customer shall be charged only for the quantity of wastewater discharged to the sewer connections to the customer's property, provided the customer demonstrates annually to the satisfaction of the Director the amount of wastewater actually discharged monthly and annually from the property to the City sewer system.
- E. The above sewer charges shall be billed (i) effective the date of the sewer connection or (ii) as otherwise provided by written agreement of the customer and the Director.

2. Pretreatment Monitoring Program Charges

Every person required to obtain a permit under Title 16 of the Santa Barbara Municipal Code shall be required to pay fees and charges as set forth below:

- A. Where no more than one wastewater analysis per year is necessary and a composite sample is not required:
 - 1. \$100.00 per permit per year
 - 2. \$100.00 per resample
- B. Where sampling (i) is necessary no more than two times per year and (ii) requires collection of a composite sample or more than one analysis:
 - 1. \$150.00 per permit per year
 - 2. \$100.00 per resample
- C. Where sampling (i) is necessary more than two times per year and (ii) requires collection of a composite sample or more than one analysis:
 - 1. \$1,100.00 per permit per year
 - 2. \$100.00 per resample
- D. Where there is an application to discharge contaminated storm water or groundwater to the sewer system, a non-refundable fee of \$100.00 shall be paid.
- E. A fee of \$100 per year shall be charged to permit each rainwater diversion valve.

3. Sewer Service Connections.

A. The following charge shall apply for each connection of a sewer lateral to the City sewer system:

The following service charge shall apply to all discharges of wastewater permitted pursuant to Municipal Code Section 16.04.080 and 16.04.090:

\$9.00 per gallon of the rated capacity of the tank discharging the wastewater.

5. Effective Date.

With respect to rates and charges that appear on monthly billings, the effective date shall be for bills dated July 1, 2004 or later.

WATER AND SEWER BUY-IN FEES

Sections 14.08.050 and 14.48.010 of the Municipal Code authorize the establishment by resolution of fees to be paid for connections to the City water and sewer systems, respectively; and water and sewer buy-in fees are appropriately assessed on the basis of the flow capacity of the meter serving a given use.

The City Council, upon recommendation of the Water Commission, has determined the appropriate charges to be assessed for new connections to the City water and sewer systems for the purpose of buying into the existing assets of those systems.

1. BUY-IN RATES

Except as provided herein, the following water and sewer buy-in fees shall be collected prior to the Public Works Director’s approval to: 1) connect to the City water or sewer system, or 2) to commence a discharge into the City sewer system from new construction or from a newly created dwelling unit. Such buy-in fees shall be in addition to fees assessed under other resolutions for the labor, materials, equipment, and other City costs necessary to construct the actual connection to the water or sewer system.

2. REGULATIONS REGARDING ASSESSMENT OF BUY-IN FEES

The following regulations shall apply to the assessment of water and sewer buy-in fees:

- A. The term “multi-family residential dwelling unit” as used herein shall mean any attached dwelling unit, including attached condominiums and secondary dwelling units.
- B. Water and sewer buy-in fees shall not apply to:

1. Connections to serve facilities owned and operated by City programs funded by the General Fund; and
 2. Water system connections for public fire hydrants, private fire hydrants, and private fire lines.
- C. A sewer buy-in fee shall not apply to a water meter that is classified as "Irrigation" in the City billing system.
- D. A water buy-in fee shall not apply to a connection to the City's reclaimed water distribution system when such connection is made for the purpose of displacing existing usage of water from the City's potable water distribution system.
- E. In the case of an application for a water or sewer connection to serve a parcel where connections already exist, credit shall be given for existing connections such that the water and sewer buy-in fees shall be based on the net increase in meter capacity. EXCEPTION: There shall be no buy-in fee assessed for the installation of a meter to serve a legally existing residential dwelling unit that is already served by another City water meter when such installation is done for the purpose of providing separate metering to such dwelling unit.
- F. A reduction in meter size may be approved by the Public Works Director in accordance with applicable resolutions; however, there shall be no refund of buy-in fees upon such reduction.
- G. In a case where the buy-in fee cannot be reasonably determined using the meter capacity method contained herein, a water and/or sewer buy-in fee may be determined by estimating the net new usage of water, converting such usage to an equivalent number of 5/8" meters, and multiplying said equivalent number times the buy-in fee for a 5/8" meter.
- H. For the period from July 1, 2003 through June 30, 2005, the Public Works Director may approve a 50% reduction of the sewer buy-in fee for a sewer connection that results in the discontinued use and the abandonment, per City standards, of a functioning and legally existing septic tank or other on-site sewage disposal system. It shall be the responsibility of the property owner to apply for such reduction in accordance with procedures established by the Public Works Director and to perform such abandonment in accordance with City requirements, including but not limited to inspection of such abandonment.

WATER RATES AND FEES

Chapter 14.08 of the Santa Barbara Municipal Code authorizes the City Council to set fees for water meters and water service;

Section 14.12.010 of the Santa Barbara Municipal Code authorizes the City Council to set the rate for City water for private fire services when the use of a meter is not required; and

The City does currently and wishes to continue to have in effect a water rate structure that reflects an adequate supply of water and promotes the efficient use of such water by its customers.

DEFINITIONS

Wherever used in this resolution the following quoted words shall have the meanings set forth below:

- A. "Account holder" means the person or entity responsible for payment for water service at a particular property, as shown in the City's water billing records.
- B. "Base allotment" means the average monthly consumption on record with the City for the most recent complete off-peak period, or such other level of consumption determined by the Director to represent the average monthly off-peak water usage by a particular customer. An off-peak period for any given customer shall be a period comprised of the service periods charged on bills dated January through June.
- C. "Director" means the Director of the Department of Public Works or his designated representative.
- D. "Hcf" means one hundred cubic feet.
- E. "Service" or "water service" means water provided by or through the water distribution facilities of the City.

1. WATER SERVICE RATES

The following provisions shall govern all fees related to water service for metered connections to the City water system:

- A. **MONTHLY SERVICE CHARGE.** A monthly service charge shall be collected for all connections, without regard to actual water use, if any, as follows:

Monthly service charges for connections located outside the City limits shall be 130% of the above charges.

B. **USER CLASSIFICATIONS.** For the purposes of assessing metered water charges provided for in Subsection C below, user classifications shall be as follows:

1. Residential Single Family Detached: Applicable to all meters serving one detached dwelling unit.
2. Multifamily 1-4 Units: Applicable to all meters serving two or more detached dwelling units and all meters serving 1, 2, 3, or 4 attached dwelling units.
3. Multifamily Over 4 Units: Applicable to all meters serving five or more dwelling units, any of which are attached.
4. Commercial: Applicable, without regard to meter size, to all accounts serving mercantile buildings, motels and other short term lodging establishments, office buildings, institutional buildings, schools, churches, and other commercial establishments.
5. Industrial: Applicable to all meters serving laundries (other than self-service laundries), manufacturing facilities, and other industrial facilities.
6. Irrigation-Potable: Applicable to meters substantially limited to outdoor water use and subclassified as provided in Subparagraph a. through d. below. All meters under this classification shall be subject to interruption upon declaration of a Stage Three Drought Condition. There shall be no connection between a meter served under this classification and any dwelling or commercial or industrial structure. Any request to convert from this user classification to any other classification shall be accompanied by the payment

of a conversion fee that shall be in addition to any other fees provided for herein. Such fee shall be in an amount determined by the Director to equal the savings that accrued to the customer during the previous twenty-four (24) months as a result of being served under this classification.

- a. Irrigation-Agriculture: Applicable only to Potable Irrigation meters that serve bona fide commercial agricultural enterprises, including nurseries. A bona fide commercial agricultural enterprise is one that grows and sells one or more type of agricultural or horticultural products, for the purpose of producing income from the sale of these products. The amount of water made available in each block of metered water usage under this sub-classification shall be based solely on the area that is planted and irrigated as part of the enterprise. As a condition of the right to receive Irrigation-Agriculture service, the Director may require an Account holder to submit to the Director any documentary or other evidence necessary to establish to a reasonable degree of certainty that the property served by the meter is being used to conduct a bona fide commercial agricultural enterprise as defined above. Such evidence may include tax returns, bills of sale, or similar documents.
- b. Irrigation - Recreation: Applicable only to Potable Irrigation meters that serve areas used primarily for passive or active recreational purposes, including parks, playgrounds, golf courses, school yards, and publicly owned open spaces and landscaped areas. The amount of water made available in each block of metered water usage under this sub-classification shall be based solely on the number of acres of planted area served by the meter.
- c. Irrigation-Commercial: Applicable to Potable Irrigation meters serving properties that are primarily commercial, industrial, or institutional in use.
- d. Irrigation-Residential: Applicable to Potable Irrigation meters serving properties that are primarily residential in use or are zoned for residential use.

7. Recycled Water: Applicable to all meters providing reclaimed wastewater.

8. Outside City Limits: Applicable to all meters serving properties that are outside the City Limits of the City of Santa Barbara.

C. **METERED WATER CHARGE.** In addition to all other charges imposed by Chapter 14.08 of the Santa Barbara Municipal Code, including but not limited to the monthly service charges set forth in Subsection III.A. above, water use shall be charged according to the following block rates for those user classifications defined in Subsection B above. Usage shall be measured in units of 100 cubic feet (hcf).

Upon finding that there are adequate water resources available to allow such use, the Director may also authorize the sale of up to a total of 21,780 HCF (50 acre feet) per year at the first block rate for use in refilling the Andre Clark Bird Refuge.

c. Irrigation - Commercial

d. Irrigation - Residential

Each meter in this sub-classification shall be assigned, for the purposes of billing, to one or more residential meters on the property. Metered water shall be billed as if it were used through the residential meter or meters to which it is assigned and at the corresponding block rates. Alternatively, an account holder may elect to be charged on the basis of the following acreage allotment, in which case such election shall remain in effect for at least twelve months:

8. Outside City Limits. Metered water charges for service to properties located outside the City limits shall be 130% of any corresponding in-City rate.

D. **FAILURE TO CONNECT TO RECYCLED WATER SYSTEM.** Where the Director has determined that use of recycled water is feasible at and on a particular property and has notified the account holder for the meter serving such property of this fact, and thereafter the user has failed to substitute recycled water use for potable water use, the charge for provision of potable water use shall be double the otherwise applicable charge for metered water.

E. **GRANTING OF ADJUSTMENTS TO EXTRAORDINARY WATER CHARGES.** Upon an account holder's application that is 1) received within 45 days of a relevant billing date, 2) submitted on a form provided by the Finance Director, and 3) supported by detailed written documentation, the Finance Director, or a designee of the Finance Director, shall have the authority to make adjustments to

extraordinary water charges in the event of hidden leaks, undetected line breaks, or other circumstances that are demonstrated to be beyond the reasonable control of the account holder. Such adjustments shall be made in accordance with guidelines approved by the City Administrator's Office. However, such adjustments shall in no case result in a cost per Hcf that is less than the Block 1 rate for residential customers located within the City limits. The decision of the Finance Director, or said designee, regarding any such adjustment shall be final. Adjustments shall be allowed under this section only once per account, per account holder.

F. MISCELLANEOUS SERVICES. The following miscellaneous fees related to water service shall be charged and collected upon demand:

G. CHANGE OF ACCOUNT HOLDER UPON TERMINATION OF TENANCY. Upon termination of utility service by an account holder who is a tenant, the property owner, or agent thereof, shall automatically become the account holder, provided that the City has on file a written request from such property owner or agent authorizing such change.

2. NON-METERED PRIVATE FIRE SERVICES

Payable monthly, the rates for City water for private fire services when the use of a meter is not required pursuant to Section 14.12.010 of the Santa Barbara Municipal Code shall be as follows:

3. WATER SERVICE CONNECTIONS

All determinations of the size and location of water service connections, water main connections, and meters shall be subject to the approval of the Director. The Director may waive the fee for a service connection or main connection to the recycled water system upon a finding that such connection will promote the efficient and beneficial use of recycled water and will displace existing usage of the City's potable water supply. Fees related to water service connection to the City water system are as follows and are in addition to buy-in fees established by the City Council in separate resolutions:

- A. Payable at the time of request, service fees for new service connections to the City water system and for water service relocations shall be as follows:

A water service relocation of up to 10 feet or the addition of a meter to a service connection that has an existing meter, except as provided above, shall be charged at the cost of labor and materials plus overhead, provided that installation of a new service connection is not required.

For 1" and 2" service connections and manifolds, subject to the prior approval of the Director, a credit of \$800.00 against the otherwise applicable service connection fee may be applied when said service connection is to be installed by the City simultaneously with and in the same customer-excavated trench as a private fire line or private water main.

- B. Payable at the time of request, fees for water service main connections to the City water system, including private fire lines and other private mains, shall be as follows and shall be in addition to any applicable fees for trench inspections and encroachment permits:

Fees for other combinations shall be charged at the cost of labor and materials, plus overhead. The fees for water service main connections shall include only the materials (tee, valve, and valve box) and labor for tapping into the City water system, and does not include excavation, pipe extension, or any other costs. In the event the existing water main or water service main connection is damaged during attachment, an additional fee of \$150 per lineal foot of water line needing repair or replacement shall be charged to the person(s) who caused such damage.

4. SETTING OF WATER METERS, TEMPORARY FIRE HYDRANT METERS AND TEMPORARY RECYCLED WATER METERS

Fees related to setting of water meters, temporary fire hydrant meters and temporary recycled water meters shall be as follows:

B. Pursuant to Section 14.25.060 of the Santa Barbara Municipal Code, the temporary use of a meter providing recycled water shall be charged at the same rates as for a temporary fire hydrant meter, except that the metered water cost shall be charged at the prevailing unit rate for recycled water customers.

With respect to rates and charges that appear on monthly billings, the effective date shall be for bills dated July 1, 2004 or later.
