The Architectural Board of Review (ABR) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: Proposal to demolish the existing 1,656 square foot gas station and construct a new 3,332 square foot one-story building for Wachovia Bank on a 26,605 square foot lot in the C-2 Zone. The proposal includes a walk up depository, ATM, new site landscaping, 15 new parking spaces, 3 bicycle spaces, and a new trash enclosure. The project requires Development Plan Approval by ABR for the allocation of 1,676 square feet of new non-residential square footage.

Public comments will be allowed during review of the project by the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing.
