**4. CDHSC VOTE ON FY 2012-13 CDBG/HUMAN SERVICES FUNDING RECOMMENDATIONS**

The subcommittee appointed to formulate the final funding recommendations, based on the CDHSC’s rankings and recommended funding amounts, made its presentation to the full committee.

Motion 1: J. Motion 4: J. Cook moved to approve the subcommittee’s recommendations for People’s Self-Help Housing (Gang Prevention – Youth Education and Housing the Homeless). G.Gorga seconded the motion. The motion passed unanimously with M. Just abstaining.
