STAFF REPORTS/DISCUSSION

- 1. Subcommittee report and CDHSC Vote on FY 2015-16 Human Services/CDBG Funding Recommendations that will be sent to City Council on March 24, 2015.
 - S. Faulstich presented the subcommittee's recommendations. The dollar amounts presented were based on the full committee's average recommended funding amounts and scoring, which were used as a starting point for fine tuning. Full funding and moderate increases were made to the higher scoring proposals; those with mid-level scores were adjusted for slight increases or level funding; and those with lower scores were reduced in funding or not recommended for any funding.

The following motions were made in the Public Service category:

1. A. Redit motioned that the subcommittee's recommendations for CIYMCA's proposals (My Home and Noah's Anchorage) be approved; D. Orchowski seconded. The motion passed by majority voice vote, with Y. Curiel and D. Ramirez abstaining.

2. D. Ramirez motioned that the remaining subcommittee recommendations be approved as submitted; A. Redit seconded. The motion passed by majority voice vote.

The following motion was made in the Capital category:

- Y. Curiel motioned that the subcommittee's recommendations for Capital funding be approved; A. Redit seconded. The motion passed by majority voice vote.
- 2. Cancellation of Regular CDHSC meeting on March 24, 2015 in order for the Committee to attend the Public Hearing on Funding Recommendations before City Council on that same date.

The committee voted by majority voice vote to cancel the March 24 meeting. (M – Gorga/S – Faulstich)
