Brian Bosse gave the staff report explaining the need for the new lease agreement with Brophy & Sons, Inc. and provided the basic terms of the proposed lease. He clarified that the average base rent was \$35,800.

Moved to recommend City Council approval of a 23-year lease agreement with Brophy & Sons, Inc., doing business as Brophy Brothers Restaurant and Clam Bar and On The Alley, at an average base rent of \$35,800 per month or 10% of gross sales, whichever is greater. Kelly/Sloan 6-0.
