## NOTICE OF A PUBLIC HEARING OF THE HISTORIC LANDMARKS COMMISSION

The Historic Landmarks Commission (HLC) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for 10 rental residential units to be developed under the Average Unit Density (AUD) program on an 18,750 square foot lot. This includes demolishing an existing single-family residence (610 Castillo St.), constructing eight new residential units, and retaining two existing single-family residences (612 and 618 Castillo St.) located on separate parcels. Both properties will be merged through a Voluntary Lot Merger. The eight new units will be developed in four new buildings consisting of one triplex, two duplexes, and one new single-family residence. The resulting 10 units will have an average unit size of 1,130 square feet and will result in 15,652 square feet of development, including garages. 20 covered parking spaces are proposed. The project requires a Concept Review by Planning Commission for the AUD development at high density (28-36 du/acre) and on a lot greater than 15,000 square feet in size.**

Public comments will be allowed for consideration by the HLC as part of the public hearing process. The HLC is the Commission appointed by the Council to review and make recommendations regarding the possible designation of historic resources. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to [HLCSecretary@SantaBarbaraCa.gov](mailto:HLCSecretary@SantaBarbaraCa.gov).

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. This type of notification is done as a courtesy and does not require 10 day advance notice.

This system allows you to manage subscriptions to City email lists that cover a wide range of City topics and services, including agendas sent for all Design Review meetings. Since all agendas would be sent, users of this service would need to check each agenda for their particular project of interest.

Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Commission took action or rendered its decision.
