NEW BUSINESS

1. Presentation on Proposed Capital Projects to be funded by Unencumbered Redevelopment Agency Funds – For Information and Discussion

Recommendation: That the council receive a presentation from <u>Assistant Public Works Director Pat Kelly</u> and <u>City Administrator Jim Armstrong</u> regarding proposed capital projects to be funded by unencumbered Redevelopment Agency bond proceeds and ask questions regarding the given information.

Info: Redevelopment agencies sell bonds to pay for redevelopments. The later increase in property taxes is then used to pay off the bonds. Redevelopment agencies now have to dissolve and get rid of all property and cash on-hand. The City has roughly \$14 million in bond proceeds at its disposal. These funds can be spent on projects for which the bonds were originally sold, are in the project area, or are immediately adjacent.

HEALTH AND SAFETY SUBCOMMITTEE REPORT

Member S. Aldana reported that the Neighborhood Health, Safety & Outreach Subcommittee met and discussed beautification projects, specifically medians on the Westside as well as improvements to the Ortega pool site, movie events in Westside park and residential parking permit process.
