FOR THE CHAPALA STREET BRIDGE REPLACEMENT PROJECT**

A Draft Mitigated Negative Declaration has been prepared for the following project, pursuant to the State of California Public Resources Code and the "Guidelines for Implementation of the California Environmental Quality Act of 1970," as amended to date.

**PROJECT LOCATION: 200 Block Chapala Street**

**PROJECT DESCRIPTION:** The project would demolish the existing 4,655 square feet (s.f.) bridge deck and replace it with a 2,740 s.f. bridge deck. The south side of the new bridge deck would be supported on piles and a foundation behind the existing sandstone abutment. The north side of the new bridge would be supported by a new abutment that would be located to align with the existing sandstone walls upstream of the bridge and the existing bank downstream of the bridge. The new bridge would provide one vehicular lane in each direction and a five foot sidewalk on each side. New bridge railings and approaches to the bridge would be constructed.

**DRAFT ENVIRONMENTAL DOCUMENT:** An Initial Study and a Draft Mitigated Negative Declaration (DMND) have been prepared for this project and are available for review and comment. The DMND examines environmental impacts which may be associated with this project. Significant environmental effects identified in the DMND which are anticipated as a result of the project include impacts related to Air Quality (asbestos), Biological Resources, Cultural Resources, Geophysical Conditions, Hazards, and Water Resources. The DMND includes proposed mitigation measures to mitigate potentially significant impacts to a less than significant level.

**DOCUMENT AVAILABILITY:** The DMND is available for review at the Planning Division, 630 Garden Street City Clerk's Office, 735 Anacapa Street and at the Public Library at 40 E. **FINAL ENVIRONMENTAL DOCUMENT:** Following the end of the DMND public review period, a Final Mitigated Negative Declaration including responses to comments will be prepared, and a subsequent noticed public hearing will be held at the Planning Commission to consider actions to approve the project.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised in written correspondence delivered to the Planning Commission, or in a public hearing on the project.
