DRAFT FISCAL YEAR 2016 - 2021 CAPITAL IMPROVEMENT PROGRAM

The streamlined process provides the Planning Commission the opportunity to review and comment on the Street Capital Program and other Draft CIP projects. The Transportation Circulation Committee and the public have provided input regarding future Streets Capital Improvement projects and related Program budget development. Other Committees, Boards and Commissions that review and advise the City Council on various program areas have reviewed the CIP projects in their purview and have provided recommendations to the City Council.

Rebecca Bjork, Public Works Director, introduced Brandon Beaudette, Administrative Analyst, who gave the Staff presentation. The following City Staff were available to answer any of the Commission's questions: Hazel Johns, Airport Director; Andrew Bermond, Airport Project Planner, Jessica Grant, Transportation Project Planner; Pat Kelly, Assistant Public Works Director/City Engineer; Steve Greer, Environmental Analyst; Gary Horwald, Fleet Manager; Victor Garza, Parking Superintendent; Scott Riedman, Waterfront Director;

Jill Zachary, Assistant Parks and Recreation Director; Captain Joe Torres, Police Department; and Jim Dewey, Facilities Manager.

Chair Thompson opened the public hearing at 1:22 P.M.

Lesley Wiscomb, Park and Recreation Commission Chair, reviewed the 2016-2021 CIP for Parks and Recreation and commented on how public safety and park infrastructure are a number one priority. Would like to see funding for the Parks and Recreation Master Plan, and for street trees called for in the Urban Forest Management Plan.

With no one else wishing to speak, the public hearing was closed at 1:25 P.M.

Commissioners Pujo and Higgins desired to learn more about available funding for the Safe Routes to School Program, especially in the vicinity of Peabody Elementary School and extended to the intersection of Alamar and State Streets, and will meet with Staff separately.

Commissioners Comments:

- Commissioners Lodge and Jordan would like to see a higher priority placed on some Parks and Recreation projects, such as Franceschi Park Renovation and the Urban Forest Management Plan Implementation, both of which have financial deficiency that would be exponentially multiplied in future years if not addressed now.
- Many Commissioners expressed concern for public safety and strongly desire to see a higher funding priority placed on the New Police Department Headquarters Building.
- Commissioners Campanella and Lodge would like to see the Airport's Hollister Drainage Improvement project completed sooner rather than later in the budget cycle.
- Commissioner Lodge would like to see the Library's Central Library Roof Terrace Renovation project moved up in the budget cycle as it does not have an associated high cost.
- Commissioner Schwartz recommended that Capital Improvement Projects categorized as 'essential' and having a lower cost be prioritized higher.
- Commissioner Campanella noted that it is up to the City Administrator to determine priorities and did not see anything in the CIP that is frivolous. The projects are needed and well thought out.
- A majority of the Commission expressed appreciation for the work done by all City departments working on the complexity of balancing community needs with financial constraints in the development of the CIP.
- Commissioner Jordan would like to see projects prioritized at both the department and City-wide levels. He found it disconcerting that this CIP report continues to lack editorial comment and does not specifically target needs that continue to erode the community's sense of being. He could not support a recommendation to City Council.

Commissioner Schwartz left the dais at 2:45 P.M. and returned at 2:49 P.M.
