(Proposal for minor changes to existing signage for an existing gas station, and additional signage for a new car wash. A new ExtraMile wall sign is proposed with 15.5 inch letters, one wall logo sign is to be removed, the existing ground sign is to be partially refaced, and seven new car wash signs are proposed. The existing total square footage for the gas station signage is 51.8 square feet, the total proposed is 121.55 square feet. The linear building frontage is 120 feet. The allowable signage is 90 square feet.)

(Exceptions are requested for wall sign letters to exceed 12 inches and for total square footage to exceed 90 square feet. Project requires exception findings.)
