(Proposal for a new Sign Program for the Montecito Country Mart. The application includes three new monument signs, new signage for 14 tenants, 26 new and/or replaced signs. The total proposed new signage is 369.24 square feet. Four tenants will retain their existing signage at 18.74 square feet each for a total of 74.96 square feet. The total signage on site will be 444.20 square feet. The proposal includes ground lighting fixtures at each of the three monument signs. An Exception is requested to exceed the maximum allowed square footage. The linear building frontage is 290 feet. The allowable signage is 90 square feet.)
