(Proposal for two halo-lit aluminum and Plexan wall signs, one awning sign, and one aluminum projecting sign. Total signage for this leasehold space will be 33.35 square feet. The previously approved iron sign bracket will be reused.)

1. The medallion logo at the front elevation shall be reduced to 12" in diameter.
2. The "Gold's Gym" lettering on the entry awning needs to be a more muted shade of yellow. The applicant also has the option to consider lettering on a yellow awning.
3. On Sign A, remove the letters but keep the medallion logo, reduced to 24" wide.
4. For all halo lit letters, reduce the thickness of the letter returns to 1-1/2" if possible.
5. Confirm that there is no face lit signage.
