



## NOTICE OF PUBLIC HEARING OF THE SINGLE FAMILY DESIGN BOARD

The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues regarding the subject property below:

### **320 SANTA CRUZ BLVD**

Project Description: **Proposal to construct a 455 square foot second floor addition, a 19 square foot first floor addition, a 190 square foot second floor deck, a 300 square foot terrace, and demolition of 192 square feet of accessory space. The existing 982 square foot one-story single-family residence with a detached 296 square foot one-car garage is located on a 4,801 square foot lot in the Hillside Design District. The proposed total of 1,768 square feet is 74% of the maximum floor to area ratio.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing.
