The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to permit the "as-built" replacement and expansion of a**

wooden staircase and landing and a new entry door into the existing attached 400 square foot two-car garage on an existing, 1,354 square foot two-story single-family residence located on a 12,000 square foot parcel in the Hillside Design District. The existing 1,754 square foot residence is 44% of the maximum floor to lot area ratio. Staff Hearing Officer approval is requested for the "as-built" replacement and expansion of the stairs and landing to encroach into the interior yard setback. The parcel is located in the Appealable Jurisdiction of the Coastal Zone and requires Coastal review of a Coastal Exemption. The proposal will address violations of the enforcement case (ENF2010-00744).

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.
