The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

**Project Description:** Proposal for an exterior remodel and 504 square feet of one-story additions to an existing 1,971 square foot one-story single-family residence. The proposal involves the conversion of the existing 470 square foot two-car garage into habitable area and the construction of a new 626 square foot attached three-car garage at the rear of the property and involves 152 cubic vards of grading. The proposed total of 3,571 square feet located on a 22,345 square foot lot in the Hillside Design District is 76% of the maximum floor to lot area ratio guideline.

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
