The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

**Project Description: This is a revised proposal to increase the size of the approved additions from 168 to the proposed 282 square feet of additions to an existing three-story 3,119 square foot single-family residence located on a 10,389 square foot lot in the Hillside Design District. The proposed addition includes a 165 square foot upper floor addition, a 35 square foot entry addition, and an 82 square foot addition and remodel to an existing ground floor bedroom/bathroom. The proposed residence will total 3,388 square feet. The maximum floor-to-lot area ratio is 84% which is based on a net total of 3,190 square feet, and includes a 50% reduction (197 square feet) of the existing basement square footage. The proposal will address the violations listed in ZIR2010-00407.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
