The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for an interior remodel and minor exterior alterations to an existing one-story 3,333 square foot single-family residence, including a two-car garage, located on a 20,037 square foot lot in the Hillside Design District. Exterior alterations include a new French door on the north elevation, new windows on the east and south elevations, and three new skylights. Staff Hearing Officer approval is requested for a zoning modification to allow alterations within the required interior setback.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
