The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to replace the original 1,182 square foot single-family residence and attached 312 square foot one-car garage that was destroyed in the Tea Fire. The proposal includes construction of 542 square feet of additions, which include a new 197 square foot one-story and a new 345 square foot two-story addition. The footprint of the original residence was non-conforming to the location within the required front and interior setbacks. The proposed 542 square foot addition is proposed to comply with the required setbacks. Parking will be maintained with the non-conforming 312 square foot one-car garage. The proposed total of 2,036 square feet, on a 7,097 square foot lot located in the Hillside Design District, is 69% of the maximum required floor-to-lot-area ratio.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
