The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal involves fire damage repairs, remodel, 756 square foot conversion of the existing attic to a new third story, and a 150 square foot new addition (50 square feet on the first, second, and the new third story) to an existing single-family residence. Approximately 336 square feet of the existing 553 square foot attached garage will be converted to habitable floor area, resulting in a 217 square foot one-car garage. The proposal includes one new uncovered parking space. The proposal will result in an approximately 3,022 square foot three-story single-family residence, located on a 34,308 square foot lot, and is 62% of the guideline floor-to-lot area ratio (FAR). The project will address violations identified within enforcement case ENF2010-00361.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
