The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for alterations to an existing 6-foot tall, 130 linear foot stucco wall**

located along the front property line. Alterations include adding eight new stone clad columns, adding a stone cap along the entire length of the wall, and adding two pedestrian gates, one 6-foot 6-inch wood gate, and a 6-foot wrought iron gate. The alterations result in an increase in height by approximately 10-inches at the locations of the new columns. An 8,331 square foot single-family residence is currently under construction and was approved under MST2008-00221. Proposal includes Staff Hearing Officer review for requested zoning modifications.

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.

The scope of this project may be modified under further review. Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
