The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for a 216 square foot one-story addition to an existing 1,336 square**

foot one-story, single-family residence and an attached one-car garage, located on a 7,405 square foot lot in the Hillside Design District. The alterations include converting the existing breezeway to a new enclosed entry addition and a new dining room addition, and alteration to the existing roofline. Other site improvements include a proposed new six-foot tall plaster garden wall, a new 3.5-foot tall plaster wall and driveway gate, and the existing "as-built" deck to be reduced to a 4-by 8-foot Juliet style balcony. The proposed total of 1,552 square feet is 51% of the maximum floor-to-lot area ratio (FAR). The project includes Staff Hearing Officer review for requested zoning modifications and will address the violations identified in ZIR2011-00290.

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
