The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to construct a new 230 square foot second-story addition and interior remodel to an existing 535 square foot detached one-story accessory building and two-car garage. The 7,500 square foot parcel is currently developed with an existing 1,340 square foot one-story single-family residence, and a detached 338 square foot two-car garage with an existing 197 square foot accessory building. The proposal will result in a new 500 square foot two-story accessory building, with an attached 262 square foot one-car garage, and one new uncovered parking space. The proposed total of 2,105 square feet is 69% of the required floor-to-lot area ratio (FAR). The project includes Staff Hearing Officer review for requested zoning modifications.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
