**APPLICATION OF PAUL ZINK, ARCHITECT FOR RONALD & LAURA BONNEAU, 525 CONEJO ROAD, APN 019-062-004, A-1 ONE-FAMILY RESIDENCE, GENERAL PLAN DESIGNATION: MAJOR HILLSIDE (MST2010-00139)**

The 6,531 square foot project site has frontage on to Conejo Road and Conejo Lane. Previous development on site consisted of a single-family residence, which was destroyed in the Tea Fire. The proposed project involves the construction of a 1,622 square foot single family residence and one-uncovered parking space. The new residence has been designed with a pitched roof which will increase the building height by seven-feet over what previously existed. The discretionary applications required for this project are Modifications to permit new construction within the required thirty-five (35') foot front and both fifteen-foot (15') interior setbacks (SBMC §28.15.060).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Section 15301 & 15305.

You are invited to attend this hearing and address your verbal comments to the Staff Hearing Officer. The appeal, accompanied by the appropriate filing fee per application, must be filed at the Planning & Zoning Counter within ten calendar days of the Staff Hearing Officer's decision.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
