The proposed project involves a remodel and a 334 square foot one-story addition to an existing 2,030 square foot, one-story, single-family residence, and the demolition of the existing 334 square foot detached garage and 30 square foot shed and construction of a new 455 square foot two-car garage on a 31,720 square foot lot located in the Hillside Design District and the Appealable Jurisdiction of the City's Coastal Zone.

The discretionary application required for this project is: a Coastal Development Permit (CDP2011-00015) to allow the proposed development in the Appealable Jurisdiction of the City's Coastal Zone (SBMC §28.44)

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Section 15301 (minor additions to existing facilities).

If you, as an aggrieved party or applicant, disagree with the decision of the Staff Hearing Officer regarding the outcome of this application, you may appeal the decision to the Planning Commission. The appeal, accompanied by the appropriate filing fee per application, must be filed at the Planning & Zoning Counter within ten calendar days of the Staff Hearing Officer's decision. If the Planning Commission's decision is appealed, and if the City Council approves the project, then it is appealable to the California Coastal Commission under California Public Resources Code §30603(a) and SBMC §28.45.009.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
