APN: 043-162-013, R-3 MULTI-FAMILY RESIDENCE ZONES, GENERAL PLAN DESIGNATION  
(15-27 DU/ACRE): MEDIUM - HIGH DENSITY RESIDENTIAL (MST2013-00502)**

The 5,000 square foot lot is developed with a 1,404 square foot residence, a 185 square foot detached accessory building, and a 274 square foot deck. The proposed project includes the demolition of the existing accessory building and 117 square feet of the existing building pad, and the construction of a 340 square foot one-car garage. The discretionary application required for this project is an Interior Setback Modification to allow the proposed garage to be located within the required six-foot interior setback (SBMC § 28.21.060 and SBMC § 28.92.110).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Act Guidelines Section 15301 and 15305 (Existing Facilities and Minor Alterations in Land Use Limitations).

The appeal, accompanied by the appropriate filing fee per application, must be filed at the Planning & Zoning Counter within ten calendar days of the Staff Hearing Officer's decision.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
