Draft Santa Barbara Climate Action Plan

The Draft Climate Action Plan identifies strategies to reduce carbon emissions generated within the City of Santa Barbara that contribute to climate change (energy, travel and land use, vegetation, waste reduction, and water conservation measures), and strategies to plan for adaptation to climate change. The Plan addresses climate change issues for the period to 2030, per direction of the Santa Barbara General Plan and California Global Warming Solutions Act (AB 32).

If you challenge the Plan approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice or in hearing comments or written correspondence delivered to the City Planning Division during the public review period.
