### How Much is the Rebate?

Any combination of “Pre-Qualified Equipment” may qualify for a one-time **rebate up to \$2,000 per meter** serving irrigated area (**\$4,000 per site**) for commercial, multi-family and HOA sites.

- **Irrigation Equipment:** 50% of the cost of drip irrigation parts, sprinkler system efficiency retrofits, sprinkler nozzles (delivering 1”/hour or less with correct pressure), pressure compensating heads, pressure regulators.
- **Water Wise Plants, Mulch, and Permeable Landscape Material:** 50% of the cost of water wise plants, mulch and permeable landscape to include gravel, cobbles up to 4”, flagstone or similar with a minimum of 4” spacing. Planted areas must be covered with a 3-inch layer of mulch. Decks and hardscapes including decomposed granite (D.G.) are not eligible.
- **Smart Irrigation Controller:** 50% of the cost of a weather-based or soil moisture sensor irrigation controller and required weather module. Smart irrigation controllers must automatically adjust for changes in weather to be eligible.
- **Pool Covers:** 50% of the cost of a pool cover, maximum of \$300 per pool cover.
- **Synthetic Turf:** Existing irrigated lawn area square footage eligible. Only actual cost of turf material and infill eligible.

### How Do I Participate?

- Step 1:** Make an appointment for a “Pre-Qualification Inspection” site visit with a Water Conservation Program representative. If your project qualifies, you will receive the pre-qualified list of items eligible for rebate (see reverse).
- Step 2:** Purchase and install equipment denoted by Water Conservation staff under the heading of “Pre-Qualified Equipment” and retain receipts. Projects installed within 120 days of the date of the Pre-Qualification Inspection are given priority funding.
- Step 3:** Call for a Post-Inspection appointment. Ask your contractor for a separate invoice for materials only. Be ready to show your finished project and provide receipts. Rebate check will be issued within 4-6 weeks of Post-Inspection.

### TERMS & CONDITIONS

1. The Applicant applying for the rebate must have authority to make changes to the property.
2. The “Service Address” must be served by City of Santa Barbara water. Rebates shall be on a one-time basis per account.
3. Only Pre-Qualified Equipment as determined by a Water Conservation staff member, upon verification of anticipated water savings, shall qualify for a rebate. This is a performance-based rebate program; project must result in a net reduction in total landscape water consumption for the site.
4. Filling out this application does not guarantee funding. Funding is granted on a first-come, first-served basis while funds last. Rebate amounts are subject to change without prior notice.
5. The purchase and installation of all equipment denoted by Water Conservation staff under the heading of “Pre-Qualified Equipment” must be installed within 120 days of the date of the Pre-Qualification Inspection to be given priority funding. However, all funds are on a first-come, first-served basis.
6. A Post-Installation Inspection to verify model, type and installation is required. Before and after photos are required.
7. Applicant must submit legible copies of the valid, dated sales receipts and/or contractor invoices with labor separated from materials. Rebate available only on items purchased after date of the pre-inspection. Only the retail cost of material will be rebated.
8. The reverse side of this form must be completely filled out and signed.
9. The City of Santa Barbara is not responsible for any tax liability which may be imposed as a result of payment of any rebates. The City of Santa Barbara is not providing tax advice, and any communication by the City of Santa Barbara is not intended or written to be used, and cannot be used, for the purpose of avoiding penalties under the Internal Revenue Code.
10. Customers are responsible for complying with all rules and regulations.
