SUBJECT: T-Hangar Lottery Applicants

Recommendation:

That Airport Commission hold a lottery to determine the order in which Mr. Barry Shulman and Mr. Adrian King will be added to the Airport T-Hangar Waiting List.

Background:

The T-Hangar Waiting List was developed to provide an orderly and transparent means to fill vacancies in the Airport's 24 T-Hangars. The purpose of the lottery is to add qualified applicants to the T-Hangar Waiting List through an open, public process.

As directed by Airport Commission, if less than 25 applicants appear on the T-Hangar Waiting List, Airport Department invites interested parties to participate in a T-Hangar Waiting List Lottery. Lotteries occur no more frequently than quarterly.

Airport Department advertised the latest lottery application period on FlySBA.com. Applications were accepted until 5:00 p.m. on September 1, 2010.

During the latest application period, two complete applications were received from Mr. Shulman and Mr. King.

A lottery will be held to determine the order in which the applicants will be added to the T-Hangar Waiting List. At this time there are no other names on the waiting list.
