



## NOTICE OF PUBLIC HEARING OF THE ARCHITECTURAL BOARD OF REVIEW CONSENT CALENDAR

The Architectural Board of Review (ABR) will hold a public hearing at its Consent Calendar to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues regarding the subject property below:

### **100 ADAMS RD**

Owner: CITY OF SANTA BARBARA

Project Description: **Proposal for site remediation at the Goleta West Sanitary District Facility to extract and treat contaminated soil and ground water as required by the Santa Barbara County Fire Department. The proposal includes the installation of mechanical equipment to include two air compressors, a skid-mounted vacuum blower, two polyethylene fluid storage tanks, four activated carbon vessels, and associated conduit to be located at the rear of an existing cinder block masonry building. The proposal also includes a corrugated metal panel structure to shelter and protect the equipment. The project will require Planning Commission review for a Coastal Development Permit.**

Public comments will be allowed during review of the project by the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to [ABRSecretary@SantaBarbaraCA.gov](mailto:ABRSecretary@SantaBarbaraCA.gov).

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. Actions on the Consent Calendar agenda are reported to the Full Board at the next regular meeting. The Full Board has the discretion to ratify or not ratify the Consent Actions. The Consent Calendar reviewing member of the ABR may refer items to the Full Board for review. Decisions of the ABR may be appealed to the City Council. For further information on appeals, contact Planning Division Staff or the City Clerk's Office. Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the date the action is ratified at the next regular Full Board meeting of the ABR.
