Project Description: Proposal for a new compressed natural gas (CNG) fueling facility for MarBorg Industries. The proposal includes the construction of a new 8 foot tall concrete masonry unit (cmu) wall and two 7 foot tall chain link gates to enclose the 2,040 square foot fueling facility area. The project is located on a 29,555 square foot lot located in the Non-Appealable Jurisdiction of the Coastal Zone and requires Staff Hearing Officer Review for a Coastal Development Permit.

Public comments will be allowed during review of the project by the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division. P.O. Box 1990. Santa Barbara. This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The Consent Calendar reviewing member of the ABR may refer items to the Full Board for review. Decisions of the ABR may be appealed to the City Council. For further information on appeals, contact Planning Division Staff or the City Clerk's Office. Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the date the action is ratified at the next regular Full Board meeting of the ABR.
