(Proposal to replace a 48-inch tall section of CMU wall along San Pascual Street, replace railroad ties with a CMU wall not to exceed 36 inches in height along Cota and San Pascual Streets, install a new 5-foot wood fence, 14.5 feet in length at the northeast property line. Zoning modifications were approved for the CMU wall at San Pascual Street to exceed 42 inches in height at the front property line and for the new 5-foot wood fence to exceed 8 feet in height when its height is combined with existing retaining walls at the property lines. The project will address violations in ENF2010-00315.)

### (Project requires compliance with Staff Hearing Officer Resolution No. 026-11.)

The applicant was absent but the item was opened for review to take public comment.

Public comment: Joyce McCullough, Habitat for Humanity: concerned that the fence at the top of the hill was included in the proposal. Discussed the possibility of Habitat cutting down a portion of the tall retaining wall between the properties or mitigating its appearance with vine planting.

Continued one week with the comment that plans must be updated to reflect Staff Hearing Officer approval.
