

## NOTICE OF PUBLIC HEARING OF THE ARCHITECTURAL BOARD OF REVIEW

The Architectural Board of Review (ABR) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: Revised proposal to result in five residential units instead of four. Proposal to demolish the existing single-family residence at the rear of the property and construct a two-story 3,999 square foot triplex with six garage spaces and two uncovered parking spaces. The structure will consist of two two-car garages and two one-car garages on the first floor, two units on the second floor, and one two-story unit. The existing one-story duplex and two uncovered parking spaces will remain at the front of the 11,580 square foot lot. The project will address violations under enforcement case ENF2005-00016.

Public comments will be allowed during review of the project by the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to <a href="mailto:abrsecretary@santabarbaraca.gov">abrsecretary@santabarbaraca.gov</a>.

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
