The Architectural Board of Review (ABR) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for alterations to the rear unit (1806 Gillespie) and abatement of violations for unpermitted work under enforcement case ENF2012-00461. The proposal would unenclose 241 square feet of habitable space to create a front porch, enclose the existing second-story deck at the rear to create a 241 square foot second story addition, and enclose a porch at the rear for a 29 square foot addition to the first floor. The project includes removal of an as-built breezeway and construction of a new 262 square foot second-story deck above a new one-car carport between the two units. The site would remain non-conforming with three rather than four parking spaces.**

Public comments will be allowed during review of the project by the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to: ABRSecretary@SantaBarbaraCA.gov.

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. Decisions of the ABR may be appealed to the City Council. For further information on appeals, contact Planning Division Staff or the City Clerk's Office. Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
