The Architectural Board of Review (ABR) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to paint a mural of approximately 10 feet by 60 feet on the Cottage**

Grove Avenue side of the International Autohaus building and to permit that side of the building to be an ongoing canvas for temporary murals on a rotating basis of nine months to a year. The project is intended as a means of graffiti abatement.

We recognize the ABR may or may not agree to provide that mechanism, and would decline our case until they have seen appropriate designs and paint chips. In the case where they could not approve a mural-to-be-designed in place of the existing one, we would appeal that to City Council and present the case there. The thinking is that City Council would be able to implement that mechanism as a new process.

Public comments will be allowed during review of the project by the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to ABRsecretary@SantaBarbaraCA.gov.

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
