## NOTICE OF PUBLIC HEARING OF THE ARCHITECTURAL BOARD OF REVIEW

The Architectural Board of Review (ABR) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for the demolition of an existing 1,400 square foot duplex to the**

**rear of the site and construction of a new 1,400 square foot duplex in the same location on an 8,700 square foot parcel. The duplex will include a 558 square foot covered porch on the ground floor, a 302 square foot uncovered deck on the second floor, and an approximate 457 square foot uncovered roof deck. Four covered tandem parking spaces will be included. Other site work will include the replacement of existing fencing with new site walls, a new planter, new driveway, and new landscaping. The existing four unit apartment building at the front of the site requires approval of as-built window replacements and storage. Staff Hearing Officer approval is required for zoning modifications related to building separation and open yard requirements, and a Coastal Development Permit. Three parking waivers are required from Transportation Division prior to building permit issuance. This proposal will address violations identified in Zoning Information Report ZIR2015-00524.**

Public comments will be allowed during review of the project by the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to [ABRsecretary@SantaBarbaraCA.gov](mailto:ABRsecretary@SantaBarbaraCA.gov).

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. This type of notification is done as a courtesy and does not require 10 day advance notice.

This system allows you to manage subscriptions to City email lists that cover a wide range of City topics and services, including agendas sent for all Design Review Meetings. Since all agendas would be sent, users of this service would need to check each agenda for their particular project of interest.

Decisions of the ABR may be appealed to the City Council. For further information on appeals, contact Planning Division Staff or the City Clerk's Office. Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
