Project Description: This is a revised project description. Proposal for alterations to an existing 3,857 square foot commercial building. The proposal includes door and window alterations, new outdoor seating area, parking lot restriping, new exterior colors, new rooftop equipment, and new landscape plan. No

new floor area is proposed. Staff Hearing Officer review is requested to allow minor door and window alterations to the building within the front setback and to allow a trash enclosure to be located within the

interior (east) setback.

Public comments will be allowed during review of the project by the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
