The Architectural Board of Review (ABR) will hold a public hearing to review architectural design-related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for a new residential project using the Average Unit-Size Density**

**Incentive Program. The project will comprise the demolition of an existing 3,690 square foot daycare building and construction of a 7,170 square foot, three-story building containing 11 residential units. The unit mix will be four, one-bedroom units and seven, two-bedroom units ranging in size from 644 to 1,008 square feet with an average unit size of 835 square feet. The proposed density on this 10,558 square foot parcel will be 45 units per acre on a parcel within the Priority Housing Overlay, 37-63 swelling units per acre. Also proposed is a 5,359 square foot ground-floor garage containing 11 spaces, covered bicycle parking, a trash enclosure, and 372 square feet of private outdoor living space.**

You are invited to attend the hearing and address your comments to the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome; mail to ABR Secretary, P.O. Box 1990, Santa Barbara, CA 93102-1990 or email to [ABRSecretary@SantaBarbaraCA.gov](mailto:ABRSecretary@SantaBarbaraCA.gov). Please note that the ABR may not have time to consider written comments received after 10 a.m. on the day of the meeting.

If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
