Project Description: **This is a revised project description: Proposal for the addition of a unit to an**

**existing single-family residence. Project is comprised of the construction of a two-story dwelling unit at the rear of the parcel, as well as an 874 square foot, second-story addition to an existing 1,292 square foot, single-family residence. Unit mix will include 1 three-bedroom unit and 1 four-bedroom unit ranging in size from 1,529 to 2,166 square feet with an average unit size of 1,848 square feet. Also proposed are 2 two-car attached garages.**

You are invited to attend the hearing and address your comments to the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Please note that the ABR may not have time to consider written comments received after 10 a.m. on the day of the meeting.

If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
