The Architectural Board of Review (ABR) will hold a public hearing to review architectural design-related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for an addition to an existing duplex. Project comprises 549 square feet of second-floor additions to a unit within an existing 2,084 square foot, two-story duplex. Proposal includes enclosing the second-floor entry walk, stairs, and landing into 127 square feet of habitable space, and construction of 422 square feet of additional living space. Also proposed are a 280 square foot upper level deck, a new two-car carport, and alterations to an existing driveway gate, landscaping, and the existing parking areas.**

You are invited to attend the hearing and address your comments to the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Please note that the ABR may not have time to consider written comments received after 10 a.m. on the day of the meeting.

If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. To be informed of future hearings, you may:

Office hours are 8:30 a.m. to 4:30 p.m., Monday through Thursday, and every other Friday (see [SantaBarbaraCA.gov/Calendar](http://SantaBarbaraCA.gov/Calendar) for closure dates).
