The Architectural Board of Review (ABR) will hold a public hearing to review architectural design-related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to convert an existing single family dwelling unit to a two-unit short**

term rental by dividing the structure internally into one, two-bedroom short term rental unit and one, one-bedroom short term rental unit. Existing development on the site consists of a two-story, 1,508 square foot, two-bedroom single family residence with two uncovered parking spaces. External alterations include the removal of an exterior door and relocating an existing driveway gate. The new project also proposes to permit an unpermitted kitchen on the second story to serve the upstairs short term rental unit, to remove an unpermitted sink on the first floor, and to add a bathroom sink to a downstairs bathroom. A previous project for the site was approved on December 5, 2016 under the Master Application number MST2016-00514 which proposed to convert the residential unit to one, two-bedroom short term rental unit. The project requires Development Plan Approval findings for conversion of residential floor area into commercial use.

You are invited to attend the hearing and address your comments to the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Please note that the ABR may not have time to consider written comments received after 10 a.m. on the day of the meeting.

ADDITIONAL INFORMATION: This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. To be informed of future hearings, you may:

Decisions of the ABR may be appealed to the City Council. For further information on appeals, contact Planning Division staff or the City Clerk's Office. Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
