The Architectural Board of Review (ABR) will hold a public hearing to review architectural design-related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to convert temporary commercial floor area to permanent floor area.**

**Project consists of the conversion of four temporary modular classrooms, totaling 7,450 square feet, to permanent commercial floor area to be used by the Boys & Girls Club for a quasi-public use. The temporary modular classrooms were permitted in 2001 along with the removal of four parking spaces. No exterior changes are proposed for the modular buildings. Project requires Planning Commission review for a Development Plan Approval and a Conditional Use Permit Amendment.**

You are invited to attend the hearing and address your comments to the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Please note that the ABR may not have time to consider written comments received after 10 a.m. on the day of the meeting.

If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
