The Architectural Board of Review (ABR) will hold a public hearing to review architectural design-related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for exterior alterations to an existing motel. Project consists of the removal of a 3'-6" overhang on the first floor of a 3,089 square foot motel, and the construction of a six foot overhang as well as a new trash enclosure. A like for like replacement of a window is also proposed for the site. Project requires a Minor Zoning Exception for the trash enclosure located in the north interior setback.**

You are invited to attend the hearing and address your comments to the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Please note that the ABR may not have time to consider written comments received after 10 a.m. on the day of the meeting.

If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
