The Architectural Board of Review (ABR) will hold a public hearing to review architectural design-related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for the redevelopment of an existing residential duplex in the Coastal Zone. Project consists of the demolition of the majority of the existing 1,094 square foot, single story duplex, and the construction of 2,667 square foot, three story duplex. Also proposed are site work, landscaping, and four on-site parking spaces. Project requires review by the Staff Hearing Officer for a Coastal Development Permit.**

You are invited to attend the hearing and address your comments to the ABR. The ABR is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the ABR's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Please note that the ABR may not have time to consider written comments received after 10 a.m. on the day of the meeting.

If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
