### **PLEASE BE ADVISED**

CEQA Guidelines §15183 Exemptions (Projects Consistent with General Plan). Under this California Environmental Quality Act (CEQA) Guidelines section, projects with new development (new nonresidential square footage or new residential units) qualify for an exemption from further environmental review documents if (1) they are consistent with the General Plan development density evaluated in the 2011 General Plan Program Environmental Impact Report, and (2) any potentially significant project-specific impacts are addressed through existing development standards. Section 15183 exemptions are determined by staff based on a preliminary environmental review process. A decision-maker CEQA finding is required for a Section 15183 exemption. City Council General Plan environmental findings remain applicable for the project.

(Proposal for an exterior remodel of an existing multi-unit residential project. Project consists of replacing all exterior guardrails and handrails on the second story walkway, new windows and doors to be replaced in existing openings, new paint, and replacing the existing patio fences with new wooden fences. Also proposed are the permitting of unpermitted changes to laundry room and the construction of a new waste and recycling enclosure. Project proposes to abate all violations identified in Zoning Information Report ZIR2017-00246. Project requests a Minor Zoning Exception for a trash enclosure proposed within two interior setbacks.)

(Proposal for Americans with Disabilities Act (ADA) upgrades to an existing 4,899 square foot hotel. Project consists of a new ADA parking space and upgraded exterior ADA access in the form of a new ADA lift adjacent to the front entry. Minor landscape alterations are also proposed as part of this scope of work.)
