PROJECT DESCRIPTION: Proposal to permit various unpermitted conditions on a multi-unit residential site. Project consists of reducing the number of units from 11 to 9, per a 1975 Planning Commission Condition of Approval, permitting an unpermitted garden area that displaced three required parking spaces, permitting unpermitted doors, decks, stairs and railings at several units, and minor additions to two of the units. The project also includes storage lofts and other alterations to the interior configuration of various units. Planning Commission review is requested for a parking modification for a reduction in parking from the 13 required to 3 provided, and an interior setback modification. The project also require a waiver from the Architectural Board of Review for an Alternative Open Yard Design. This project will address violations in Zoning Information Report ZIR2017-00334 and Enforcement Case ENF2017-01216. **FOR MORE**
