Project includes: re-roofing with matching shingles, a portion of the structure to be re-roofed with a green roof, replacing all windows and doors, repainting the exterior, removing wood siding and replacing with stucco, replacing blue fabric awnings with new, restriping and repairing the existing parking lot, and adding 1 new van accessible parking space.
