PROJECT DESCRIPTION: This is a one-time Pre-Application Consultation. Proposal for two residential duplexes. Project consists of the demolition of an existing one-and-two-story single residential unit and the construction of two, two-and-three-story duplexes. Units will range in size from 2,412 to 3,640 net square feet. Site work will include new landscaping, driveways, courtyards, and patios.
