NOTICE OF A PUBLIC HEARING: ARCHITECTURAL BOARD OF REVIEW

PROJECT DESCRIPTION: Proposal for a remodel of an existing commercial shopping center. Project consists of a façade remodel including new colors, copper gutters, sandstone bases, and extended eaves. A new 33 foot tall entry tower is proposed for a new grocery store location. A reallocation of non-residential floor area is proposed with demolition of a 1,697 square foot mezzanine and construction of a 606 square foot loading dock. Also proposed are changes to parking lot circulation and configuration, new landscaping and site lighting, and storm water management improvements. Project requires a Minor Zoning Exception for an increase in building height within the north interior setback. An application for the removal of two street trees, a *Metrosideros Excelsa* and *Ficus Benjamina*, has been submitted for review by the City's Parks and Recreation Department.
