**NOTICE OF A PUBLIC HEARING: ARCHITECTURAL BOARD OF REVIEW**

**PROJECT DESCRIPTION:** Proposal for a façade remodel and non-residential addition to an existing commercial structure. Project consists of repainting the existing exterior brick and installation of wood cladding to existing architectural features. The project also includes a new elevator shaft to improve access to the second floor, new railings and stairs, and new rooftop equipment. Also proposed is a reconfiguration of the parking lot, and installation of new landscaping at the upper and lower parking lots. Project proposes to reallocate square footages to exclude existing mechanical equipment rooms and add 85 square feet of net new non-residential floor area. Project requires a Development Plan Approval finding from the Architectural Board of Review as well as a waiver for an alternative parking lot landscape design.
