**PROJECT DESCRIPTION:** Proposal for a three-story, three-unit residential condominium development on an approximately 9,100 square foot vacant lot adjacent to Mission Creek. The project consists of 3, three bedroom units that will total 4,816 square feet and will comprise the second and third levels, with three covered parking spaces provided in a carport on the ground level. Three uncovered parking spaces are also proposed, as well as rooftop decks. One 20" diameter palm tree will be removed. The property is zoned R-M and has a General Plan Land Use Designation of Medium High Density Residential (15-27 du/acre).
